1. Unseat production packer at 5874' and re-dress same.
2. Using treatment packer, re-treat perforations (6165'-7098') with 238 bbls of foamed acid (Trade name: Halliburton "Moroflow"), displaced with 157 bbls N₂.
3. Recover treatment fluid by natural flow.
4. Re-seat production packer at 6800', and re-potential perforations between 6658'-6760' through annulus. Perforations below packer (6874-7098') open through tubing, but shut-in.
5. Lower zone will be re-fraced and potentialized at later date.
