5/17/85: Moved in Bobcat Rig #19. Reamed existing hole to 1060'. Drilled new hole with 7-7/8" bit. Drilled to 1033' and lost circulation. Set 6 cement plugs. Reamed hole with 9-7/8" bit. Dry drilled to 1406'.

5/10/85: Ran 1406' 8-5/8" casing. Cemented with 100 sx Class C with 2% CaCl₂. Drilled out with 7-7/8" bit 5/22/85.

5/22 to 6/13/85: Drilled with 7-7/8" bit. Mud wt - 9.1, vis - 45, WL - 30. Drilled to 5411' and reached total depth. Logging 6/13/85.
