Propose to cement behind 7" production casing per the following procedure:

Kill well. Pull tubing. Set a retrievable bridge plug at 1800' and cap with 10' of sand. Top of cement found by temp survey at approx. 1340'. Perforate 7" casing 20' above top of cement. Set packer 200' above perfs. Establish circulation. Pump 11 bbls. of colored dye. Pump sufficient Class C cement to circulate. WOC. Pull packer and bridge plug. Run tubing.
