Propose to kill well and release packer and pull out of hole and tag plug back depth. Perf intervals 2428-58, 2462-68. Run in hole 1 jt fiberglass tailpipe, coated packer and 2-7/8 coated tubing. Land tailpipe at 2280 and set and pressure test packer. Swab and flow 30 min. Stimulate with 15 tons liquid CO2 and ball sealers. Flow test and return well to production.
