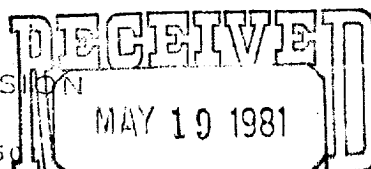

On 4-27-81 Aztec Drilling (Rig #56) spudded a 12-1/4" hole at 4:00 p.m. Drilled to a TD of 707' and ran 8-5/8" casing set at 707'. Cemented with 500 SX Class H cement. Plugged down 11:30 a.m. 4-28-81. Circulated 225 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2638' and ran 5-1/2" casing set at 2638'. Cemented with 850 SX Class H cement. Plugged down 11:30 p.m. 5-2-81. Circulated 240 SX. Currently waiting on completion unit.
