On 9-7-83 CO2-In-Action (Rig No. 18) spudded at 12-1/4" hole at 5:00 pm. Drilled to 705' and set 9-5/8" casing. Cemented with 375 sacks class H and additives. Plugged down at 11:15 am on 9-8-83. Circulated 150 sacks cement to pit. Tested casing for 30 min at 600 psi and OK. Pumped 130 bbl LCM pill and circulated. Total loss 115 bbl. Ran 7" casing and set at 2725'. Cemented with 1200 sacks class H and additives. Plugged down at 6:30 am on 9-13-83. Circulated 420 sacks cement. Rig released at 8:30 am. on 9-13-83. Currently waiting on completion unit.
