On 10-9-83 Aztec Drilling Co. (Rig #56) spudded a 12 1/4" hole at 7:45 pm. Drilled to 722' and set 9 5/8" casing. Cemented 390 sacks Class H and additives. Circulated 127 sacks and plugged down at 2:45 pm on 10-11-83. Tested casing at 600 psi for 30 min. and OK. Logged and ran 7" casing and set at 2775'. Cemented with 850 sacks class H & additives. Plugged down at 12:43 am on 10-14-83. Circulated 255 sacks cement and tested casing at 1500 psi for 30 Min & OK. Rig released at 2:45 am on 10-14-83. Currently waiting on completion unit.
