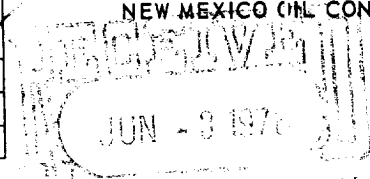

This test was completed 9-4-73 as a Shut-in Dakota dry, natural gas well and has been shut-in since this time waiting for pipeline connection. We have recently hooked-up four wells on the Berlier tract to the east which will be selling into a pipeline. As the Julien well is across Interstate 25 highway and the ATS&P railway, it has been our decision to test the four producing wells for a period (6 months) prior to boring beneath Highway & Railway. We request the Secretary-Director of the Commission to grant continued S.I. until such time as we can get the well hooked-up under rights given him in Rule 201, Section B (1).
