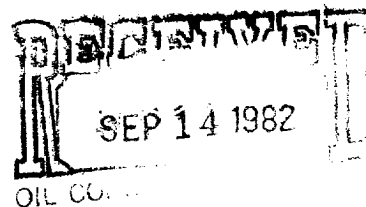

We propose to plug this well as follows:

45 sacks Class C Cement with 3% CaCl, pumped at 680', the top of the plug is expected to be at 500' but will be tagged after WOC 3 hours.

15 sacks Class C Cement with 3% CaCl, pumped at surface and a dry hole marker will be set.
