DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Test was spudded on May 4, 1953, at 10 P.M. Drilled 17 1/4" hole to 410' in sand and shale with limestone streaks. Set and cemented 14 joints (295' threads off tally) of 12 1/2" OD 54# casing at 307', using 225 sacks of cement. Cement circulated when plug was at 300'. Now drilling at 968' in sandy shale.
