The casing program was changed from that previously outlined and approved on form C-101 as follows:

Run 3 jts - new - 10 3/4" - 40# casing set @ 87' D.F. w/50 sms. reg. - 2% CaCl

T.D. at time 10 3/4" csg. was set was 663' in 8 1/2" hole. A 12 1/2" hole was previously reduced at 87' to 10 3/4" hole. Casing set solid at 87' on the shoulder and was cemented there.

Cement was hand mixed with gasoline mixer and dumped down annulus. Cement level @ 7' D.F. when job completed. Job complete at 5:00 A.M. Sept. 8, 1961.

W.O.C. - 5:00 A.M. Sept. 8 to 5:00 P.M. Sept. 9 (36 hrs W.O.C.)

Pressure test was not run. Cable tool operation. Hole was dry at time casing was run and remained dry after casing was run to a depth of 909' where first fluid was encountered.
