Plan to drill out plugs @ surface, 2460' - 2560'; 4478' - 4594' and clean out to 7750'. Plan to log well and if logs indicate, will set 5 1/2" casing and test significant zones. If well is not commercial, will P&A as per NMOCD instructions.

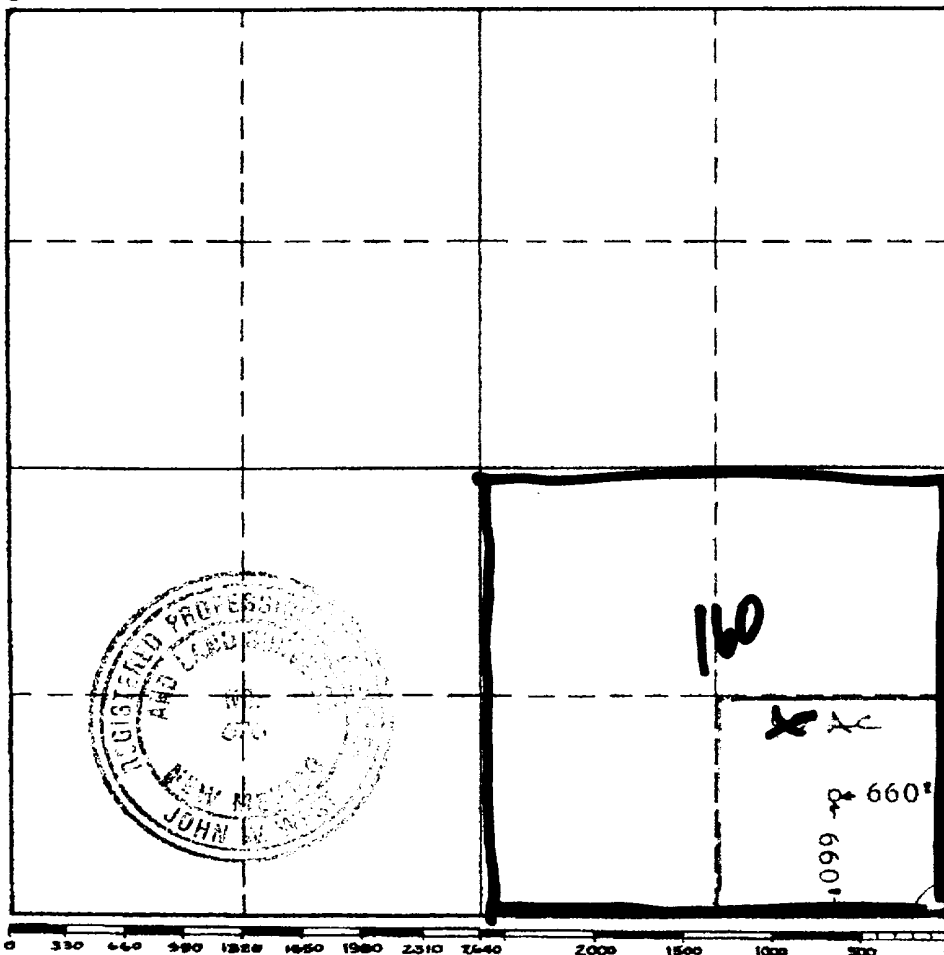
