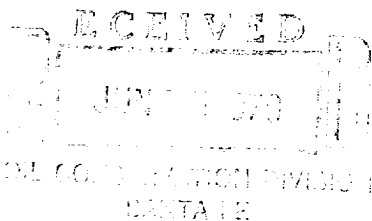

Moved in Service Unit 5-31-79. Tested casing with 2500# for 30 min. Swab down casing to 5800'. Perforated 6209', 6216', 6223', 6231', 6237', 6245', 6253', 6279', 6283', 6288', 6293', and 6298' with 2JSPF using 4" casing gun. Ran 2 7/8" tubing, packer and 120' tailpipe and spotted acid. Packer set at 6043 and tailpipe set at 6170. Acidized with 3000 gal 15% FE acid, 30% methanol and 1500 SCF CO2 dropping 1 ball sealer every 100 gal. Currently swab testing.
