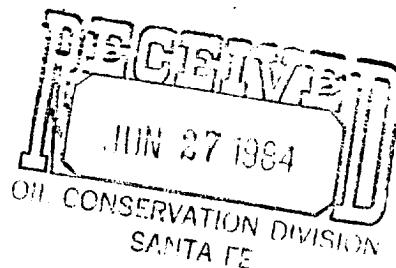

Well was drilled to 2,497 feet, and 834 feet of 8 5/8 inch surface pipe was set and cemented sealing off all known water tables. A cap was welded on top of the surface pipe so that nothing can get in or out of said pipe. It is proposed that the well be temporarily abandoned for a period not to exceed one year for further evaluation.
