Drilled to a TD of 362' and ran 8-5/8" 24# casing set at 322'. Cemented with 200 SX Class
C cement with 2% CACL. Plug down 2:00 p.m. 5-13-79. Circulated 40 SX. WOC 18 hrs.
Tested casing with 500# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling.
