On 8-13-79 Sitton Drilling Company (Rig #1) spudded a 12 1/4" hole at 6:30 PM. Drilled to a TD of 360' and ran 8-5/8" 24# casing set at 358'. Cemented with 200 sx Class C cement with 2% CACL. Plug down 9:45 AM 8-14-79. Circulated 21 sx. WOC 18 hrs. Tested casing with 1000# for 30 min. Test ok.. Reduced hole to 7-7/8" and resumed drilling.
