Drilled to a TD of 727' and ran 8-5/8" casing set at 727'. Cemented with 500 SX
Class H cement. Plugged down 4:30 a.m. 4-28-81. Circulated 247 SX. WOC 18 hrs.
Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and
resumed drilling. Drilled to a TD of 2505' and ran 5-1/2" casing set at 2498'.
Cemented with 700 SX Class H cement. Plugged down 8:30 a.m. 5-2-81.
Circulated 200 SX. Currently waiting on completion unit.
