On 4-8-81 James Drilling (Rig #7) spudded a 12-1/4" hole at 6:00 a.m. Drilled to a TD of 715' and ran 8-5/8" casing set at 715'. Cemented with 500 SX Class H cement. Plugged down 7:20 a.m. 4-10-81. Circulated 150 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2654' and ran 5-1/2" casing set at 2650'. Cemented with 750 SX Class H cement. Plugged down 2:30 a.m. 4-16-81. Circulated 240 SX. Currently waiting on completion unit.
