On 4-3-81 Layton Exploration (Rig #2) spudded a 12-1/4" hole at 5:30 a.m. Drilled to a TD of 720' and ran 8-5/8" casing set at 715'. Cemented with 500 SX Class H cement. Plugged down 8:15 p.m. 4-4-81. Circulated 152 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 3506' and ran 5-1/2" casing set at 3506'. Cemented with 1600 SX Class H cement. Plugged down 5:00 a.m. 4-15-81. Circulated 300 SX. Currently waiting on completion unit.
