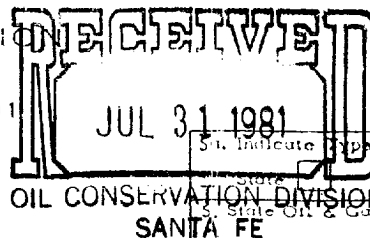

Fractured with 22000 gal. 40# gel and 27500# 8/12 sand. Flow tested thru a separator for 168 hr. with an average of 609 MCFD. Shut-in 7-24-81 for BHP build up. BHP bomb pulled 7-27-81. Well shut-in 7-27-81.
