On 6-26-81 Salizar Drilling (Rig #13) spudded a 12-1/4" hole at 3:00 a.m. Drilled to a TD of 715' and ran 8-5/8" casing set at 704'. Cemented with 500 SX Class H cement. Plugged down 1:00 a.m. 6-27-81. Circulated 215 SX. WOC 21 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2726' and ran 5-1/2" casing set at 2726'. Cemented with 850 SX Class H cement. Plugged down 12:30 a.m. 7-2-81. Circulated 220 SX. Currently waiting on completion unit.
