Started drilling on July 13, 1981, set 12" casing to depth of 80'. Set 8 5/8" casing to depth of 350'. Cement dried 18 hours and began drilling. July 17th, we lost circulation for a third time, we were very worried about getting our drill pipe stuck so we pulled out. We were at TD at 768'. We called Western to plug the well. Western plugged the well with 125 sacks of cement.
