On 12-13-83 Aztec Drilling Co. (Rig #56) spudded a 12-1/4" hole at 5:30 pm. Drilled to 721' and set 9-5/8" casing. Cemented with 390 sacks class H and additives. Plugged down at 1:00 pm and cement did not circulate. Tested casing at 600 psi and OK. Logged and ran 7" casing set at 2720'. Cemented with 850 sacks cement and additives. Plugged down at 4:00 am on 12-20-83. Circulated 185 sacks cement to pit. Tested casing at 1500 psi for 30 min and OK. Rig released at 5:00 am on 12-20-83. Moved in completion unit 1-5-84. Perforated 2132'-2286' with 2 SPF. Acidized with 4000 gals 7-1/2% HCL and additives. Flow tested thru a separator at an average of 1900 MCFD for 205 hours. Shut in well 1-24-84.
