On 10-23-83 Aztec Drilling Co. (Rig #171) spudded a 12-1/4" hole at 5:00 pm. Drilled to 723' and set 9-5/8" casing. Cemented with 390 sacks class H and additives. Circulated 283 sacks and plugged down at 7:45 am on 10-24-83. Tested casing at 600 psi for 30 min. and OK. Logged and ran 7" casing and set at 2616'. Cemented with 750 sacks class H cement and additives. Circulated 286 sacks and plugged down at 3:30 am on 10-28-83. Tested casing at 1000 psi for 30 min. and OK. Rig released at 5:00 am on 10-28-83. Currently waiting on completion unit.
