On 10-26-83 CO2-In-Action (Rig #16) spudded a 12-1/4" hole at 8:15 pm. Drilled to 723' and set 9-5/8" casing. Cemented with 390 sacks class H and additives. Plugged down at 8:15 am. on 10-27-83 and circulated 120 sacks. Pressure tested casing at 1000 psi for 30 min and OK. Logged and ran 7" casing set at 2748'. Cemented with 850 sacks class H and additives. Circulated 180 sacks cement and plugged down at 10:15 pm on 10-30-83. Tested casing at 1500 psi for 30 min and OK. Rig released on 10-30-83 at 11:45 pm. Currently waiting on completion unit.
