Propose to frac stimulate the Tubb formation to increase production. MI and RUSU. Frac with 40# HEC gelled with 2% KCL FW, liquid CO₂ and 8/16 Brady sand. Shut-in well for 1 hour then flow to tank to recover load water. Clean out sand as needed to 2235. Return to production.
