Test csg to 600 psi x ok. TD 8-3/4" hole at 2796' on 10-1-84. Run 7" csg and set at 2791'. Cemented with 650 sacks of Class H cement with additives and circ. 197 sacks. Plug down at 9:01 a.m. 10-2-84. Rig released at 12:01 p.m. 10-2-84. Waiting on completion unit.
