Ms. Gladden,

The OCD cannot accept this Remediation Work Plan as it is written. PID meter readings only represent VOC levels, and cannot be used to measure the levels of GRO or DRO. In addition, as per NMOCD Guidelines for Remediation of Leaks, Spills and Releases (Section IV.A.2.b), if a PID is used to measure BTEX the RRAL is 100 ppm. The OCD will require laboratory analysis of TPH and chlorides before we consider this site delineated. It is also advantageous to use lab data for BTEX. In the absence of lab confirmation of BTEX, all soils with PID over 100 ppm must be excavated to meet OCD standards.

OCD approval does not relieve the operator of liability should their operations fail to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the operator of responsibility for compliance with any other federal, state, local laws and/or regulations.
