Lupe,

The OCD will require a five foot excavation in the areas of S1 through S4. You may use your proposed two feet of caliche as fill, capped by three feet of clean soil. Your proposal of no excavation in the area of S5 is approved. Please be sure to correct your table (TPH and BTEX numbers are transposed).

OCD approval does not relieve the operator of liability should their operations fail to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the operator of responsibility for compliance with any other federal, state, local laws and/or regulations.
