Mike and Jennifer,

On June 10, 2013, Cimarex discovered an illegal dump (Vacuum Truck) of produced water at the Amoco Federal #3. The initial C-141 is enclosed. All the fluids from the release were contained on the well pad. As an emergency response, Tetra Tech was contacted to supervise the removal of the impacted soil and haul the soil to proper disposal. Once excavated, Tetra Tech collected field and soil confirmation samples for evaluation. Based on the results, the BLM approved the backfilling of the excavation. At this time, a closure report for the remedial activities performed at the site will be completed and submitted to the NMOCD and BLM.

On June 30, 2013, another illegal dump occurred on the well pad. The release occurred top of the previous backfilled spill site and measure approximately (30 x 60). The initial C-141 is enclosed. Tetra Tech will be onsite Wednesday (7-31-13) to excavate the spill area. Tetra Tech will collect soil confirmation samples for proper removal of the soils. We will notify you prior to backfilling the excavation. Once completed, a closure report will be submitted for review. If you need additional information let me know, thanks
