Your proposal for remediation of the above referenced release is approved. Confirmation sidewall and bottom samples will be required in the excavated areas, and an evaluation of the analytical data made, prior to backfill. Analytical data presented with this proposal shows chloride are low, which would be non-inhibitive of plant growth.

Like approval by BLM is required on Federal sites.

Please notify OCD prior to commencement of remedial activities.

OCD approval does not relieve the operator of liability should their operations fail to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. Most was contained inside the lines berm. Wind caused a spray of fluid outside berm in the pasture on the north side of the battery. The impacted area is approximately 660 x 150 feet.
