The release occurred at 8:00 am on 11/20/2014
Released: 9 bbls Oil, 24 bbls Produced Water
Recovered: 8 bbls Oil, 20 bbls Produced Water

The release was caused by a gasket failure on the fire tube of the heater treater. The release impacted the location and the surrounding pasture with the majority of the fluid release contained within the lined facility. The site is being evaluated for clean-up and a C-141 will be submitted. If you have any additional questions please feel free to contact me.
