> On April 14, 2015, NMOCD personnel performed a routine field inspection on the following well site:

> Kersey State 001 * 30-015-05178 * B-16-17s-31e * Eddy County, NM

> The attached photos were taken by the OCD field inspector. It was observed that a release of produced fluid, in excess of five bbls, has occurred, allowing fluids to pool inside the unlined, bermed battery area. At this time, OCD requests standing fluid be removed immediately. Saturated soils may be excavated and hauled to an OCD approved disposal

facility, as an immediate response action. An Initial Report Form C-141 is to be submitted to the District 2 Office not later than April 29, 2015. The impacted area will require delineation and remediation per NMOCD rules, regulations, and guidelines. A remediation proposal based on delineation results and site ranking, is to be submitted to the District 2 Office for review, not later than May 14, 2015. An attempt was made, unsuccessfully, to contact you at phone numbers OCD has on file. Please update contact information as may be available.
