Mr. Burton,

Your proposed excavation depths at the above listed site are approved. The OCD will require the following before this incident can be closed:

- A reevaluation of the depth to ground water is required. Per the ChevronTexacoTrend map and OSE database, ground water is potentially quite shallow;
- The OCD will need further chloride delineation at SP1, SP2, SP3, SP6, and SP10. Chloride delineation goals should be 250mg/kg.
- Like approval by BLM is required for federal sites.

OCD approval does not relieve the operator of liability should their operations fail to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the operator of responsibility for compliance with any other federal, state, local laws and/or regulations.
