2RP-2974 is for a release dated 2/14/2014. It showed a release of 472 mcf gas, but no liquids. **2RP-2846** is for the 2/15/2015 release, and was sent as an initial. Go ahead and include both of these RP numbers in your closure and we can close out the 2014 incident as well.

The April 29, 2015 release will be **2RP-3191**.

Osman,

I am certainly open for making this as "paperless" as possible, however, I think for the sake of clarity, for our records, I would request an amended Initial C-141 for the releases, giving your best guess estimate of what the fluid release volume may have been. Once the sites have been completed, one Final C-141 with a closure report, referencing all the RP numbers, would be sufficient for closing things out. The RP numbers are as follows:

Release dated 2/15/2015 – 2RP-2974
Release dated 6/8/2015 – 2RP-3044
Release dated 7/2/2015 – 2RP-3100

I searched the data base and email yesterday and could not find a C-141 for the April 29, 2015 release, so if you would send that one as an initial we will get it entered and I will send you the RP number for it.

Hi Mr. Bratcher,

I wanted to follow-up with you on four spills at Enterprise Field Services 30137 pipeline. Currently there is one spill cleanup project at the 30137 line that is open, dated February 15, 2015.

There were three additional pipeline spills reported to NMOCD. The events occurred on the following dates:

April 29, 2015

June 8, 2015

July 2, 2015

These events were reported as final events, since the initial liquid volume estimates were below 5 bbls for each leak.

Given the proximity of each leak, the excavation work has been combined for all of the leaks. However, during remediation, it was determined that the liquid volume from each of the leaks is larger than originally reported.

Therefore, I wanted to discuss what would be the best option for reporting and closing these cases. We would like to combine all of these events into a single report, and thus combine all of the cases into a single C-141 form.

Would this work for you? If that is the case, could you provide me with the RP numbers that NMOCD assigned to all of these cases? That way I can submit to you a C-141 form that encompasses all of these events and we can provide the appropriate reference.
