OCD concurs with BLM approval and conditions of approval for your proposal for remediation of the above referenced release. Please provide any additional data to OCD as well.

The following is intended for clarification, although it may not seem as such:

OCD notes that the Initial report C-141 lists the well as Todd 36 State 1 with an API number of 30-015-20341. ULSTR is listed as I-26-23s-31e. OCD data shows the Todd 36 State 1 (015-20341) being in F-36-23s-31e. BLM response references 2RP-3438, but lists the well as Todd 36 F SWD, with API number 30-015-20277. OCD data lists this well (015-20277) as Todd 26 G Fed 2, in G-26-23s-31e. The Lat/Long listed on the C-141 is in I-26-23s-31e, also as listed on the C-141, and is adjacent to a lease road, approximately 650 yard south of 015-20277. Please reference the 2RP number for future correspondence.

I know, the agency I work for and this response share the same acronym.
