I would like to schedule an on-site meeting at the Foster FF on Wednesday, May 20, 2015 at 2:00 PM to discuss further delineation sampling per our meeting on February 4, 2015. I conducted a site check yesterday to mark GPS points from the two previous sample events (9/4/2014 & 10/14/2014) and observed the following for discussion.

Vegetation regrowth within the excavated areas of the pipeline ROW and excavation edges. After on-site meeting discussion, further sample points for delineation purposes. General overview of excavation area (based on the site ranking of Zero with depth of ground water being greater than 100'; approximately 175' per the ChevronTexaco Trend Map).

I will contact Kevin Wilbanks of the meeting date and time also.
