Robert,

At this time, OCD approves the portion of your proposal in regard to the ground water/surface water investigation. After conversations with SLO personnel, and in the interest of consistency, target goal for chloride remediation in soils is 1000 mg/kg for this site. This will require additional excavation than what was discussed at the last OCD/COG meeting. I personally apologize for having agreed to the lesser excavation, in error. Earlier documentation does indicate the target goal of 1000 mg/kg was set early on in this investigation. In addition, Google Earth image dated 1/22/2013 shows what appears to be a produced fluid release in the area identified on the sample plat as T5, which may account for the elevated chloride levels at deeper intervals in that area.

Please advise OCD and SLO once activities at the site have been scheduled.
