The flow line leaked, causing the release. Vacuum truck(s) and roustabout crews were called. An approximate area of 20' X 20' was affected outside the battery to the south with an overspray area of approximately 60' X 60'. The wells were shut in, vacuum trucks were called to recover the standing fluid and a roustabout crew was called to repair the flow line. Excavated soils will be hauled to a NMOCD approved facility. Vertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX (chlorides for documentation). If initial analytical results for TPH & BTEX are under RRAL's (site ranking is 0) a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL's a work plan will be submitted to the OCD. Depth to Ground Water: >100' (approximately 150', Section 1, T22S-R31E, per Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0. Remediation completed according to NMOCD approved Work Plan with stipulations. Yates Petroleum Corporation requests closure.
