Thank you for discussing this incident with me even though you are not feeling well. Hope you get better soon. It is OCD's understanding that the approximately top 4' of impacted material was excavated and hauled to a disposal at the time of the release, and accounts for sample data beginning at 4' bgs. In consideration of all factors presented, OCD agrees that use of a liner is not practicable in this instance. Your proposal to defer cleanup of the remaining contamination to time of facility abandonment, or at a time when excavation and/or liner installation may be feasible, is approved. Notations to that effect will be made in OCD database.

OCD notes that the actual release site is 1.39 miles south of the Cotton Draw Ut 167H well site. Lat/Long for the release is: 32.1671N 103.7323W. The release site is on State surface and the Cotton Draw Ut 167H is on Federal surface.

OCD approval does not relieve the operator of liability should their operations fail to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the operator of responsibility for compliance with any other federal, state, local laws and/or regulations.
