The BLM remediation project (2RP-2670) was completed, but a final report was not submitted. The site was cleaned, tilled, fertilized, and seeded, but we weren't happy with the new grass growth by the end of the growing season in 2015. We were trying to allow more time before seeding and fertilizing a second time. I don't have any current photos to show change in vegetation, and frankly it fell off my radar; I will contact our area superintendent and get him to take some. What kind of closure report do you need for this one?

The second project (2RP-2492) also was completed, although I can't lay my hands on the report. It is possible that none was submitted. How would you like me to proceed?
