There is no RP number issued for this release at this time, and OCD has no record of this release having been reported. The C-141 included in this submittal lists release volume as 20 gallons oil & 20 gallons PW, with 10 gallons oil recovered. The body of the remediation proposal lists the release volume as 20 barrels oil & 20 barrels PW, with 10 barrels PW recovered & no oil recovered. Based on areal and vertical extent of impact listed in the remediation proposal, OCD believes the release is likely more than what is reported on the C-141. Please submit a corrected C-141 immediately. In addition, this proposal is not approved at this time due to the following: inconsistency in the reported release volumes, incomplete delineation in the area listed as SP1, and analytical data presented was obtained over 1.5 years ago.

OCD does have record of an open release associated with this API number. It was assigned 2RP-1724 with a release date listed as 6/17/2013.
