
Describe Cause of Problem and Remedial Action Taken.\*

Stress/fatigue of a 4 inch steel suction line caused 40 bbls of produced water to spill into the lined containment. Approximately 38 bbls of produced water were recovered and the line was repaired.

Describe Area Affected and Cleanup Action Taken.\*

The affected area is approximately 45' x 45' with all of the leak staying inside the lined battery on location. Remediation was completed by removing the contaminated materials from within the lined containment and replacing them with clean material.
