The OCD is in receipt of your work plan for the above listed release.

Your proposed excavation depths are approved with the following conditions:

- DP-1 bottom hole confirmation sample for TPH;
- DP-2 surface confirmation sample for TPH and BTEX;
- DP-3 no further action;
- DP-4 bottom hole confirmation sample for TPH and BTEX;
- DP-5 bottom hole confirmation sample for TPH and BTEX;
- DP-6 no further action.

Your proposal to blend soils to meet RRAL's is denied. The OCD does not approve of blending contaminated soils with clean soils to reach RRAL's.

OCD approval does not relieve the operator of liability should their operations fail to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the operator of responsibility for compliance with any other federal, state, local laws and/or regulations.
