Cause- Back pressure valve on separator malfunctioned causing pressure relief valve to open and spray mist across the North and Northeast side.  
Remedial Action- Backed off pressure on separator then dumped fluid from separator to water tanks.

Describe Area Affected and Cleanup Action Taken.\*

Affected area- 200 ft to the North and 100 ft to the Northeast off the pad into the pasture (Mist). The pad was also affected around the separation equipment. Cleanup Action- Micro blaze misted area. Dug up and hauled off contaminated caliche from pad. Samples from the pad were taken on June 10, 2014 in connection with 2RP-2312 before backfilling.
