Your request for closure of the above referenced release is approved by OCD, with the following notations:

- The closure approval is based on analytical data provided.
- SESI gives a site ranking of 10, which identifies RRAL for TPH at 1000 mg/kg. Several references in the proposal and the closure report refer to 5000 mg/kg as RRAL. This was also noted in the OCD proposal approval.
- Sample point 1 was never identified on any of the site diagrams.

- Photos in the closure report should show post remedial actions. The ones provided are the same photos that were in the proposal.
- Federal sites are subject to BLM requirements for closure or other disposition for the project.

OCD approval does not relieve the operator of liability should their operations fail to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the operator of responsibility for compliance with any other federal, state, local laws and/or regulations.
