The C-141 Final is being submitted based on impacted soils being disposed of at an NMOCD approved facility as required by the conditions of approval. The bioremediation process would have exceeded 180 days (12/16/2016, results enclosed), therefore the second treatment round was not undertaken. Also attached are further delineation analytical results for the S2 area, identifying chloride concentration below 250 mg/kg. EOG Y Resources, Inc. requests closure.
