Attached are the laboratory analysis and site maps for the excavated areas. Mr. Pair I understand your concern around sample point 8 which currently is excavated to a depth of 4 feet and I propose that a 20 mil liner be installed prior to backfilling. The other sample point that has elevated chloride sample point 11 was a surface sample and will have that removed during backfilling activities and a confirmation sample collected for analysis prior to backfilling that area. Sorry for teh dealy on this - I injured a knee over New years, had surgery in early January, was out for all of January, and have only worked part-time since then. This one just got lost in my email.

Remind me - did you have to notify OCD on this one? And if so, have they approved?

This report is light on on fdetails. But BLM generally does not allow chloride levels above 1,000 ppm within 4-feet of teh surface. Several of your samples exceed this. Are you proposing just to backfill with clean material? If so, I think you need to excavate a few more feet in those spots with high Chloride; then we can discuss further.
