Greetings,

The New Mexico Oil Conservation Division District 2 Office (OCD) is in receipt of a "revised" Remediation Work Plan (revised plan), dated October 10, 2011. The revised plan proposes an alternative method to the June 23, 2011 submittal, for cleanup of contaminated materials, resulting from a release of produced fluids, as referenced above. The revised plan proposes, basically, to blend all remaining contaminated material with some clean material, and use as backfill for excavations at the site.

The revised plan, as submitted, is not approved.

The original remediation proposal, dated June 23, 2011, was approved by OCD on August 4, 2011. This approval remains in effect, modified only to reflect the required project completion date, to now be January 4, 2012.
