Please find attached the final report on the Apache State SWD Pit. I have followed up on the site and everything looks good as of today. Thank you all for your time in the review and approval of this closure request.

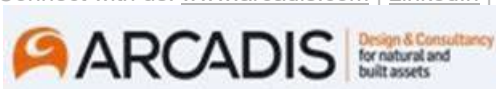
